- b. **CIF Executive Committee Nominations**

The CIF Nominating Committee, as Per Bylaw 70.E., met by conference call and nominated candidates listed (see portfolio for list) for the position of President Elect and no less than seven individuals for a one-year term, 2016-2017, to serve on the CIF Executive Committee. Additional nominations will also be accepted from the floor. **VOTE MARTY BITTER & CONSCIOUS ON OTHERS**

- c. **Proposed Bylaws 504; 1200; 1700; 1701; 1702 Competitive Cheer**

The proposed bylaw additions would add Competitive Cheer to the CIF Approved Sports. Further, these bylaw additions would require that all individuals who coach competitive cheer must fulfill nationally recognized safety training standards as mandated by A.B. 949. **APPROVED**

- d. **Proposed Revision Bylaws 1606; 2401; 2901; 2902 Competitive Equity Placement**

The proposed bylaw revision would revise the placement of teams into Regional and State Playoffs in the sports of Basketball, Soccer and Girls and Boys Volleyball to be based upon a "Competitive Equity" model and not enrollment or section divisions. **APPROVED**

- e. **Proposed Bylaws Revisions 503.B.1 - Uniform Administrative Penalty**

This proposed Bylaw Revision would create a uniformed penalty in the case where it is determined by the CIF Section that an ineligible student competed due to the failure of the school administration to submit proper CIF Section transfer eligibility application or forms which would have, had it been submitted in a timely manner and reviewed by the section, resulted in immediate eligibility in that sport. This proposal is an outcome of a Federated Council roundtable discussion. This proposal will be finalized following the January 11,

Federated Council as a 1st reading item. **APPROVED**

- f. **Proposed Revision Bylaws 206, 207, 510, 1100 – Athletically Motivated Transfers**

The proposed bylaw revisions would eliminate some wording regarding "Athletically Motivated Transfers" and would continue the language

regarding “following a coach.” This proposal is an outcome of a Federated Council roundtable discussion and direction to the Commissioners Committee. **APPROVED**

**g. Proposed Bylaws 1206 Standardized Number of Contests**

The proposed new bylaw would create a standardized number of maximum contests in sports that culminate in a Regional or State Championship. This proposal is an outcome of a Federated Council roundtable discussion. This proposal will be finalized following the January 11, 2017 Commissioners Committee meeting and distributed at the Federated Council as a 1st reading item. **APPROVED**

**h. Proposed Bylaws 900 All Star Contests**

The proposed bylaw revision would modify the wording of the current bylaw further clarifying factors determining what is an “all-star” competition and who may participate. ### X. CIF Central Section Action Items:

a. Cross Country Advisory Report:

**Proposal 1.** Passed unanimously

The Sectional Championship will include a RESERVE RACE for the alternates to the championships. The schools will pay an entry fee for the alternates and the alternates will need to wear their assigned bibs to check into the race. The clerks will check in the runners of the race to make sure only registered runners are in the race. No awards will be given in the race.

Wednesday morning, I was informed by the CIF that this is contradictory to the rule and cannot be implemented this year.

This proposal will change rule 3.1.2 of Cross Country Governing Rule, Italicized addition:

3.1.2

Entries- Varsity boys and girls only. A team will consist of 5 to 7 runners from any one school of boys and girls. Entries of less than 5 from one school will be considered individual entries, and will compete only for individual awards. Their order of finish will not be considered in the team scoring. *The alternates to the Varsity Race may run in the Reserve Race. The team will be charged the entry fee for their alternates.*

**Proposal 2.** Passed. High Desert was the dissenting vote.

The time schedule for the Sectional Championship will be the same order as the State Championship.

This proposal will change rule 3.1.7 of Cross Country Governing Rule, Italicized addition, cross out deleted:

Time schedule. ~~The time schedule for the Sectional Meet will be as follows: 11:00 AM D 5 Girls; 11:30 AM D 4 Boys; 12:00PM D 5 boys; 12:30 PM D 4 Girls; \*1:00 D 3 Girls; 1:30 Reserve race; 2:00 D 3 Boys; 2:30 D 1 Girls; 3:00 D 2 Boys; 3:30 D 2 Girls; 4:00 D 1 Boys. \*Rotate last three divisions each year.~~ *The first race for the Sectional Meet will be at 11:00 AM. The order of the races will be the same as the order California State Championships.*

This schedule would be implemented this year, since the State Meet schedule for 2016 doesn't contradict our Governing Rules. The schedule for 2016 will be:

11:00 Division IV Boys; 11:30 Division V Boys; 12:00 Division IV Girls; 12:30 Division V Girls; 1:00 Division 1 Boys; 1:30 Division II Girls; 2:00 Division III Boys; 2:30 Division 1 Girls; 3:00 Division 2 Boys; Division 3 Girls.

Note that there is no reserve race for 2016.

**Proposal 3.** Passed unanimously

Entry Fee Schedule. After discussion, the original proposal was modified to \$6.00 per athlete with a maximum of \$300. This fee schedule will be included in the Playoff Procedures of the Rules and the General Rules section of the Governing Regulations. Therefore, we will add section 1.9 Entry Fee. Italicized addition, cross out deleted:

*1.9 Entry Fee. Entry fees are \$6.00 per individual and \$300 maximum per school*

and we change 3.1.5 of the Regulations to:

3.1.5. Awards. Entry fees are \$6.00 per individual and ~~\$180~~ \$300 maximum per school. (See CIF Central Section Awards Chart in back of Constitution and By-Laws.).

If proposal 1 and proposal 3 both pass the Board of Managers, then

3.1.5. Awards. Entry fees are \$6.00 per individual *including alternates* and ~~\$180~~ \$300 maximum per school. (See CIF Central Section Awards Chart in back of Constitution and By-Laws.).

**Proposal 4** Passed unanimously.

We propose that for Cross Country only, for the Central Section, we revert back to divisional placement strictly by enrollment. The Central Section will place the largest 25% of schools larger than an enrollment of 600 in division 1, the second 25% in division 2, the third 25% in division 3, and the fourth 25% plus the extra schools into division 4, with the extra schools into Division 4. All schools with an enrollment less than 600 will be placed in Division 5.

Below is a table of the proposed divisions IF WE WERE TO USE THE PRESENT CBEDS which of course changes year to year. CBEDS taken from CIF website. There are 78 schools above 600 enrollment,  $78 \div 4 = 19$  r. 2 there below would be an example of the proposal.

This proposal follows closely the procedures used by San Diego, Southern, & Los Angeles Sections. San Diego evaluates their divisions annually and this is the procedure our Advisory Committee would like to follow.

The discussion was lengthy. It was pointed out that none of the other nine sections used competitive equity in cross country by many of the sections use competitive equity in their other sports.

There were actually two votes. The first vote was should our section use enrollment to determine the five divisions. That passed unanimously. Then the second vote was to decide which process should we implement. The vote was whether to imitate the Sac-Joaquin's method for determining divisions or the San Diego method. The Advisory Committee voted unanimously for the San Diego method.

**b. Wrestling Competitive Equity Proposal:**

The proposal is to make Wrestling in the Central Section into a Competitive Equity Model. There would be Three Divisional Meets, North, Central and South and would eliminate the Sierra/Sequoia Meet. Each Area Meet would be a 32- man bracket, in which all schools would receive one entry in each weight class. This proposal will give all schools large, medium and small the same opportunity to gain entry into the Grand Masters Meet. There will be a set amount of automatic qualifiers out of each Area Meet, with the additional entries being awarded by success by an Area in the two previous Grand Masters Meet. The spots will be given to Areas based upon the number of medals achieved at the Grand

Masters.

**c. Track & Field Competitive Equity Model:**

The proposal is to make Wrestling in the Central Section into a Competitive Equity Model. There would be Three Divisional Meets, North, Central and South and would eliminate the Sierra/Sequoia Meet. The qualifying Details for the Grand Masters will be developed by the Track Advisory.

**d. Proposal to make Girls Volleyball Championships at a single site venue a permanent concept:**

After completing two very successful years under a pilot program, the section office is requesting to make the Girls Volleyball Championships at a Single Site Venue a permanent Concept. Below are the payouts to school from the last three years. This 2014-2015 payouts were at individual school sites.

3. Record vs. Opponents in the same Division of Higher

**h. Proposed Criteria for Play-Off Seeding for Tennis, Water Polo, Volleyball, Soccer, Baseball and Softball**

**The Seeding Committee will use the mandatory coach’s rankings as a starting point for determining the seeding placement of teams. A team that receives a preponderance of the votes for a position shall receive the seed. If a no team gets a preponderance of the votes in the opinion of the committee. The committee will use the point system listed below to determine the seed.**

The process will remain as currently done with each criteria being worth one point.

1. Head to Head
2. Overall Record
3. Record vs. Common Opponents
4. Maxpreps Strength of Schedule
5. Place in Same League
6. MaxPreps Rankings

If Maxpreps does not have a Strength of Schedule, that Criteria Will Not be used.

Coaches Mandatory Rankings will be used as a starting point. If a coach does not turn in their division rankings, **THEY WILL NOT BE CONSIDERED FOR A SEEDED PLACE IN THE BRACKET.**
