VII. State CIF Federated Council Managements Services Action Items

- a. Deleting 1906.b in regards to Football Tie Breaker. Move the decision on tie breaker yardage to Blue Pages of the Handbook.

Proposal Summary: The proposed bylaw revision would delete Bylaw 1906.B that mandates the 10-yard tie breaking procedure in Regional and State Football Bowl Championships. Tie breaking language for Regional and State Football Bowl games is more appropriately placed in the "Blue Pages." **If approved in October 2017, this would take effect immediately.**

- b. Sit out period change from set date to 50% of the days in a season.

Proposal Summary: The proposed bylaw revision would change the Sit Out Period (SOP) to a standard percentage for all sports as determined by the Sections first allowable competition date through the final regular season completion date. This proposed change would ensure that all students would have the same length of SOP, regardless of the Section and Season of Sport as the SOP would be based on a standardized percentage. The year of implementation would be 2018-2019 to coincide with the State and Sections calendar revisions.

VIII. State CIF Federated Council Managements Services Non-Action Items

- a. Proposed Bylaw 207 Revisions – Transfer Eligibility, International Students. The Commissioners Committee is proposing a revision in Bylaw 207 that would further clarify the athletic eligibility of International students who transfer without a valid change of residence.

Background Summary:

The Commissioner's Committee is proposing a revision in Bylaw 207.B.(4) iv. That would further clarify the athletic eligibility of international students who are not in an approved Foreign Exchange Program who transfer without a valid change of residence.

1. Changes the language from Foreign to International Transfers
 2. International students who are not participating in a CIF approved foreign exchange program are not eligible for the Sit-Out Provision.
